(2) The Articles of Organization for the limited liability company were filed on April 24, 2024 and assigned document number L24000186411.


(3) Article IV of the Articles of Organization for the limited liability company shall be deleted in its entirety and replaced with the following:

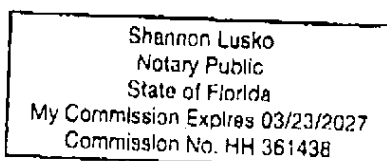
