ARTICLES OF ORGANIZATION

OF

COUCH-DESIGNS THAT INSPIRE, LLC

The undersigned, acting as the organizer of COUCH-DESIGNS THAT INSPIRE, LLC under the Florida Revised Limited Liability Company Act. Chapter 605. Florida Statutes, adopts the following Articles of Organization:

ARTICLE 1 - NAME:

The name of the limited liability company is COUCH-DESIGNS THAT INSPIRE, LLC (the "Company").
