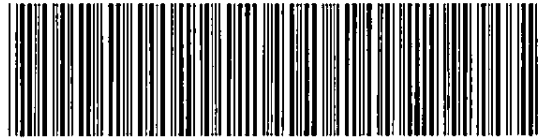




ARTICLE VIII
