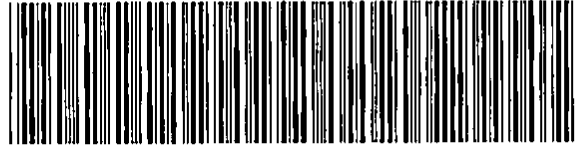

**ARTICLES OF ORGANIZATION  
OF  
TREK LEISURE VACATIONS, LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is Trek Leisure Vacations, LLC (the "Company").

**ARTICLE II. ADDRESS**

The principal and mailing address of the Company is 955 Bolero Road, Winter Garden, FL 34787.

**ARTICLE III. REGISTERED AGENT AND OFFICE**
