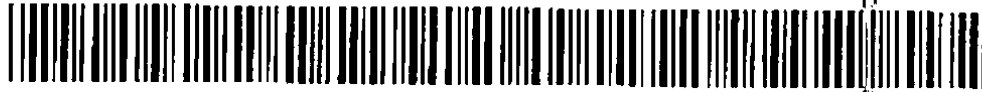

**ARTICLES OF ORGANIZATION
OF
WRH PROPERTIES II HOLDINGS - SUSAN, LLC**

The undersigned authorized representative hereby executes these Articles of Organization for the purpose of forming a limited liability company (the "Limited Liability Company") in accordance with the laws of the State of Florida.

**ARTICLE I.
NAME**

The name of the Limited Liability Company shall be WRH PROPERTIES II HOLDINGS - SUSAN, LLC.

**ARTICLE II.
DURATION; EFFECTIVE DATE**

This Limited Liability Company shall exist perpetually, effective as of May 1, 2024.
