

The termination of

any action, suit or proceeding by judgment, order, settlement, conviction, or plea of non-contenders or its equivalent shall not of itself, create a presumption that the person did not act in good faith and intaining which he or she reasonably believed to be in, or at least not opposed in the best interests of the company.
