The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Bavaro's Central Kitchen & Market, LLC (the "Company"). The Company's principal address is 514 N. Franklin Street, Suite 101, Tampa, Florida 33602, and mailing address is P.O. Box 173447, Tampa, Florida 33672. The Company's initial registered agent is David M. Jeffries, whose address is 1227 N. 

Indemnification




CERTIFICATE DESIGNATING
