**ARTICLES OF ORGANIZATION

**ARTICLE 1  
NAME**

**ARTICLE 2  
DURATION AND PLACE OF BUSINESS**

The period of duration of the Company is perpetual and its principal place of business is at 19501 W Country Club Drive, TS 04 Aventura, FL 33180.
