The street address and the mailing address of the principal office of the Company are One Independent Drive, Suite 3300, Jacksonville, FL 32202.

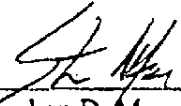

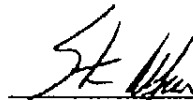
