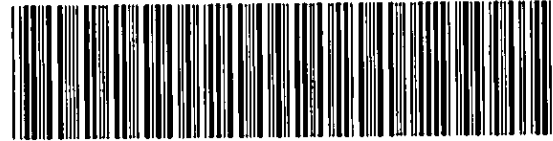

**ARTICLE I**


