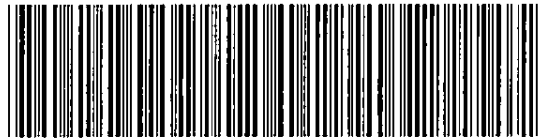

The name of the limited liability company is: Lakeland Cold Storage, LLC




