**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **ExploreRCoast LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **320 Iris St., Anna Maria, Florida 34216.**

4. Management of the Company. The management of the Company shall be vested in the manager of the Company. The name and address of the initial manager of the Company is as follows:


