ARTICLE I

The name of this Limited Liability Company is:

Without limiting any of the purposes, powers and objects of this Limited Liability Company it is expressly declared and provided that this Limited Liability Company shall have power in carrying on its own business, or for the purpose of accomplishment of any of the purposes or attainment of its objects, to make and perform contracts of any kind and description and to do any and all other acts, and to exercise any and all powers either as principal, agent or broker, conferred by the laws of Florida upon Limited Liability Companies, and which a partnership or natural person could do and exercise, and which now or hereafter may be authorized by law.




