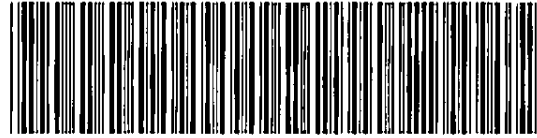





The name and street address of the initial registered agent of the Company is CT Corporation System at 1200 South Pine Island Road, Plantation, Florida 33324.


ARTICLE IV – MANAGEMENT OF THE COMPANY


