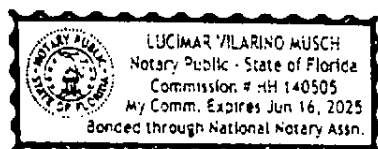
1. **Affiant Information:** My name is Elaine Ribeiro Figueira. I am competent to make this affidavit. The facts stated herein are based on my personal knowledge.
