ARTICLE I
NAME & ADDRESS

ARTICLE II
EFFECTIVE DATE

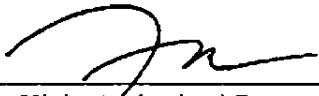

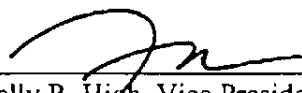
