LLC Operating Agreement

Version One

Created: April 28, 2024

Article I: Formation

- **1.1 Formation:** FLOCO Holdings LLC (the "Company") is hereby formed under the laws of the State of Florida.
- **1.2 Name:** The name of the Company shall be FLOCO Holdings LLC, which is the official name of the Company. FLOCO stands for *FLOyd COmpany*.
- **1.3 Logo:** The Company shall have four logos, with the Black Hospitalier Fox Shield being the primary logo (*See Appendix A*). The secondary logo shall be the Hunting Fox Logo (*See Appendix B*), the third-level logo shall be the Fox Head Logo (*See Appendix C*), and the fourth-level logo shall be the text logo in Aharoni (*See Appendix D*).
- **1.4 Colors:** The official colors of the Company shall be Orange, Black, and White.

Article II: Purpose

2.1 Business Purpose: The Company's objective is to conduct holding operations, encompassing strategic investments, asset management, real estate acquisitions, property management, and operational oversight, among other activities.

Article III: Members

- **3.1 Initial Members:** As a privately held family business, the initial members of the Company comprise of: $\frac{1}{2}$
 - · K. Monty Floyd
 - Kara Floyd

- Heirs as outlined in FLOCO succession plan.
- **3.2 Ownership:** Ownership interests in the Company shall be held as follows:
 - K. Monty Floyd = 50 % Shares of FLOCO (50 Shares)
 - Kara Floyd = 50 % Shares of FLOCO (50 Shares)
 - Heirs as outlined in FLOCO succession plan.
 - 1 Share of FLOCO = 1% Ownership. The value of shares is determined by the overall value of the company as appraised and valued by Ownership. FLOCO is a privately held family run Company.

Article IV: Management

- **4.1 Management Structure:** The Company shall be managed by its designated Ownership (see 3.2) and only by its designated Owners.
- **4.2 Duties and Powers:** Only listed Owners (see 3.2) or their appointed designees shall have the authority to manage the affairs of the Company, including but not limited to making investment decisions, entering into contracts, selling, purchasing, and hiring employees.

Article V: Meetings

- **5.1 Annual Meeting:** The Company is a family-owned business and as such meetings will occur as needed. There is no formal requirement for annual meetings at this time.
- 5.2 Special Meetings: Special Meetings will be held between Owners as needed. There is no formal requirement for Special Meetings.

Article VI: Distribution of Profits and Losses

- **6.1 Distribution:** Profits and losses of the Company shall be allocated to the Owners in proportion to their ownership interests.
- **6.2 Distributions:** Distributions of profits shall be made at such times and in such amounts as determined by the Owners.

Article VII: Dissolution

7.1 Dissolution: The Company shall be dissolved upon the vote of 100% of the Ownership.

Article VIII: Miscellaneous

- **8.1 Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.
- 8.2 Entire Agreement: This Agreement constitutes the entire agreement between the Owners with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements and understandings, whether written or oral.

Appendix A – This logo is the primary and main logo of FLOCO Holdings. It pays homage to the Floyd Family ancestral mascot (Fox) which is prevalent in Renaissance and Medieval family sigils and coats of arms, as well as the ancestral legacy of Gilbert de Vere who was the Prior of the Order of Saint John (Knights Hospitallers) who fought under King Richard "The Lionheart" during the Third Crusades (Maltese Cross).



Appendix B – This logo is called the "Hunting Fox" and is a secondary logo that is often used with property acquisitions or agricultural related operations. The Floyd Family cattle brand is often featured alongside this logo under those circumstances.




Appendix C – This is the "Fox Head" logo which is used on wax seals or under circumstances where the primary Shield logo can't be used due to formatting issues. The Fox Head is often parred with either the Floyd Family cattle brand or with the Hospitaller Maltese cross.

Appendix E – The official colors of FLOCO (Floyd Co) shall be Hospitaller Black (#000000) and Ferocious Fox Orange (#e25d1b).

Appendix F – Floyd Family Cattle Brand – This is the official licensed cattle brand under the laws of the State of Florida and is owned by the Floyd Family by way of their separate "Lazy Fox Farm's" agricultural operation. While this brand might appear in conjunction with approved FLOCO logos from time to time, it is not an approved FLOCO logo. It's part of a separate business operation and is not affiliated outside of loose association with the Floyd family's involvement with FLOCO Holdings LLC.



Appendix G – Medieval & Contemporary Floyd Family Mottos (Heredity) that have been accepted by FLOCO Holdings as guiding principles or core values:

"Veritas in Deceptione" - 1344 inscription on fox clad crusader shield that also depicts the black and white Hospitaller Maltese Cross (on display in Jerusalem) which is Latin for "Truth in Deception". Also, on the cross is "Victoria in Christo" which is Latin for "Victory in Christ". This shield is the inspiration for our primary logo. Stars were added to the primary logo to

depict our current American heritage.
