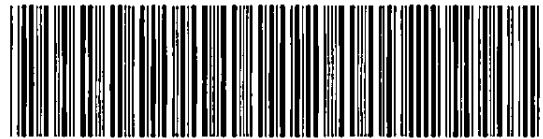

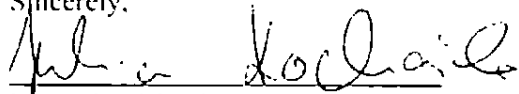
There is a conflict with the name as the business. Dandelight, LLC was opened on July 28, 2022 by an attorney, Torres Law, PA, working for the client as a Foreign Limited Liability Company of Delaware. The State of Florida opened the business and provided the document number of M22000011811. This business is currently INACTIVE with the State of Florida due to being REVOKED FOR ANNUAL REPORT as the Annual Report was never filed.


The client then began working with a new lawyer, Milam Howard, ET.AL, and he was unaware that the LLC had already been opened in Florida for the client. The new lawyer used the same name, Dandelight, LLC to open the LLC for a second time on December 22, 2022 as a Foreign Limited Liability Company of Delaware. The State of Florida allowed the business to open with the same name and provided a new document number of M22000019060. 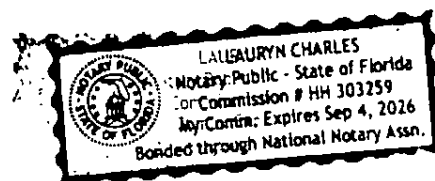

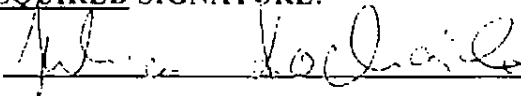
