

ARTICLES OF ORGANIZATION OF SANRON, LLC

The undersigned, being a duly authorized representative of a Member, desiring to form a limited liability company under and pursuant to the Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The principal office and mailing address of the Company is:



The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of all of the ownership interests of the Company, upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company.
