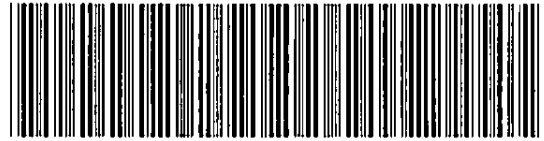

**ARTICLE I**

**Name**

## ARTICLE V

### Effective Date

The effective date of the LLC shall be upon filing.

## ARTICLE VI

### Manager Liability

A manager of the LLC shall not be personally liable to the LLC or its members for monetary damages for conduct as a manager, except for liability of the manager for (i) acts or omissions that involve intentional misconduct or a knowing violation of the law by the manager, (ii) conduct which violates the Florida Limited Liability Company Act Chapter 605, pertaining to unpermitted distributions to members or loans to managers, or (iii) any transaction from which the manager will personally receive a benefit in money, property or services to which the manager is not legally entitled. If the Florida Limited Liability Company Act is amended to authorize limited liability company action further eliminating or limiting the personal liability of managers, then the liability of a manager of the LLC shall be eliminated or limited to the fullest extent permitted by the Florida Limited Liability Company Act, as so amended. Any repeal or modification of the foregoing paragraph by the members of the LLC shall not adversely affect any right or protection of a manager of the LLC existing at the time of such repeal or modification.

## ARTICLE VII

### Indemnification

The company shall indemnify each manager against all liability, damage or expense resulting from the fact that such person is or was a manager, to the maximum extent and under all circumstances permitted by law; except that the LLC shall not indemnify a manager against liability, damage or expense resulting from the manager's gross negligence.

## ARTICLE VIII

### Signature


