ARTICLE I
NAME

The name of the Company shall be: PRECISION SURGERY CENTER, LLC

ARTICLE II
ADDRESS AND PLACE OF BUSINESS

The address of the principal office of this Company shall be 1201 JACARANDA BOULEVARD, SUITE 1283, VENICE, FL 34292, and the mailing address of the Company shall be 2389 E. VENICE AVENUE, #505, VENICE, FL 34292

ARTICLE III
PERIOD OF DURATION

The period of duration of the Company shall be perpetual.

ARTICLE IV
GENERAL POWERS

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes* (the "Act").




