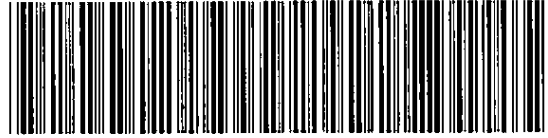

ARTICLE III – Management


The Company shall be managed by its member, as set forth in the Company’s Operating Agreement, and is therefore member-managed.
