**ARTICLES OF ORGANIZATION
OF
GRAPO LLC**

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Grapo LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal office of the Company is as follows: 428 S.W. 7 Ave., Homestead, FL 33030. The mailing address of the Company is as follows: 200 Crandon Blvd., suite 321, Key Biscayne, FL 33149.

**ARTICLE III
REGISTERED AGENT AND OFFICE**

The Company designates 200 Crandon Blvd., suite 321, Key Biscayne, FL 33149 as the street address of the initial registered office of the Company and names LP Administraciones, LLC, a Florida limited liability company, as the Company's initial registered agent at that address to accept service of process within this state.

**ARTICLE IV
MANAGEMENT**

The Company shall be conducted, carried on, and managed by at least one (1) Manager. The Manager shall also have the rights and responsibilities described in the Operating Agreement of the Company. The Managers, who shall serve in such capacity until their successors are duly elected and qualified, shall be:

ARTICLE V
DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

ARTICLE VI
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII

Additional Managers may be admitted upon the approval of a majority of the ownership interest of the Company, upon the written application of such new Manager, in the manner set forth in the Operating Agreement of the Company.


ARTICLE VIII
