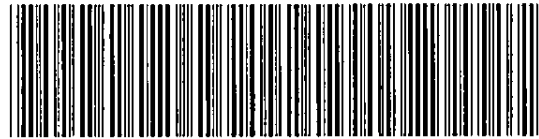





**ARTICLES OF ORGANIZATION  
RCMA CHARTER SCHOOLS, LLC**

These Articles of Organization ("Articles") are adopted and effective this 20th day of June, 2024, pursuant to Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"). The undersigned sets forth the following:

**ARTICLE I  
NAME**

The name of the Limited Liability Company is RCMA Charter Schools, LLC (the "LLC").

**ARTICLE II  
ADDRESS**

The mailing address and principal office of the LLC is: 402 W. Main Street, Immokalee, Florida 34142.

**ARTICLE III  
MEMBERSHIP AND FORM OF MANAGEMENT**

The LLC shall be Manager-Managed within the meaning of Section 605.0407, Florida Statutes, and have a single member consisting of Redlands Christian Migrant Association, Inc. (the "Member"). The Member is a Federal Tax-Exempt Entity. The LLC shall not admit any additional members at any time. The LLC shall be governed by the Act, these Articles, and the Operating Agreement, of even date herewith.

**ARTICLE IV  
PURPOSE**

The general purpose of this LLC shall be to operate exclusively for charitable, educational, scientific, or literary purposes, and in furtherance of such goals is authorized to do any and all activities which it is empowered to do under the Articles and the Operating Agreement. The LLC will also qualify for derivative tax exempt status as a disregarded entity within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or a related section of a successor statute (the "Code") and 26 CFR § 301.7701.3(a), by virtue of its relationship with the Member. The LLC will also qualify through its exempt status relationship derived from its Member as a charitable organization for purposes of receiving deductible gifts and grants within the meaning of Section 170(b)(1)(A) of the Code. Nothing herein shall be construed as allowing any activities which would jeopardize the LLC's derivative tax-exempt status from the Member or the tax-exempt status of the Member or would otherwise be inconsistent with the Member's classification as an organization described in §501(c)(3) of the Code, or as a corporation, contributions to which are deductible under §170(c)(2) of the Code. The specific purpose for which the LLC is formed is to establish, develop, maintain, improve, manage, and otherwise operate one or more public charter schools and associated uses.

**ARTICLE V  
INITIAL REGISTERED AGENT**

The name and address of the initial registered agent of the LLC is Isabel Garcia, 402 W. Main Street, Immokalee, Florida 34142.

**ARTICLE VI  
AMENDMENTS OR RESTATEMENTS**

Any amendment or restatement of these Articles of Organization shall be in writing and shall not be effective unless and until approved in writing by the Member and the LLC. No oral representations by the Member or the Managers shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, these Articles of Organization.
