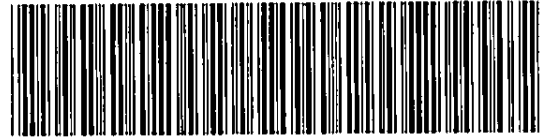

ARTICLES OF ORGANIZATION

OF

FIRST EAGLE, LLC

1. Name. The name of this limited liability company is **First Eagle, LLC** (the "**Company**"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.


