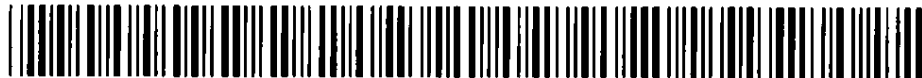

**ARTICLES OF ORGANIZATION
OF
215 PALMS, LLC**

1. Name. The name of this limited liability company is **215 PALMS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **560 10th Ave. S., Safety Harbor, Florida 34695.**

3. Registered Agent and Office. The name of the initial registered agent of the Company is **Spoor Law, P.A.** The street address of the initial registered agent of the Company is **877 Executive Center Dr., W., Suite 100, St. Petersburg, Florida 33702.**

4. Management of the Company. The management of the Company shall be vested in the manager of the Company. The name and address of the initial manager of the Company is as follows:



6. Purpose; Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
