ARTICLES OF ORGANIZATION
of
LAKETON, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "*Act*"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Laketon, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 4314 Pablo Oaks Court, Jacksonville, Florida 32224.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VII**DURATION AND COMMENCEMENT**




