

## ARTICLES OF ORGANIZATION OF BIG TREE, LLC

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

#### **ARTICLE I**

#### Name

The name of this limited liability company (the "Company") shall be:

#### **Principal Office and Mailing Address**
