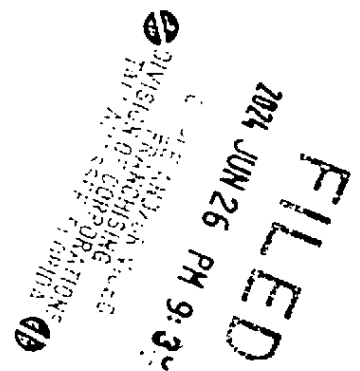
ARTICLE III.

**ARTICLE IV.**  
**PURPOSE**

The limited liability company is organized exclusively for charitable, educational, and scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code. The limited liability company is organized and shall continue to exist for the purpose of empowering individuals, families, communities, businesses, organizations, the disadvantaged, the historically marginalized, the underserved, and the unserved through the support of and providing services to and at the direction of the sole member High Alert Institute, Inc., a Florida not for profit corporation. No part of the activities of the company shall inure to the benefit of any individual and no substantial part of its activities shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the company shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office.

**ARTICLE V.**  
**POWERS**

The limited liability company shall be authorized and empowered to exercise any and all powers conferred by the Florida Revised Limited Liability Act, as may be amended from time to time, provided such powers are exercised in a manner that is consistent with, and reasonably necessary and incidental to, the objects and purposes of the limited liability company set forth in Article IV hereof. Notwithstanding any other provision of these Articles, the limited liability company will not exercise any powers or engage in any activities, other than to an insubstantial extent, that in themselves are not in furtherance of: (i) Section 501(c)(3) of the Internal revenue Code, its rules and regulations, all as amended now or hereafter, (ii) Section 170(c)(2) of the

Internal Revenue Code, its rules and regulations, all as amended now or hereafter, or (iii) the purposes of the limited liability company, as set forth herein.

**ARTICLE VI.**  
**MEMBERSHIP**

The sole member of Sustainable Resilience Solutions, LLC is High Alert Institute, Inc., which is a Florida not for profit corporation and is a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.

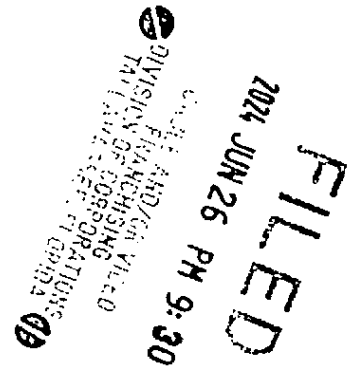
**ARTICLE VII.**  
**DURATION**

The limited liability company shall commence existence on the filing of these Articles of Organization and shall have a perpetual duration.

**ARTICLE VIII.**  
**NO PRIVATE INUREMENT**

No part of the net earnings of the limited liability company shall inure to the benefit of any director, member, trustee, officer, or any private individual (except that reasonable compensation may be paid for services rendered to or for the company affecting one or more of its purposes), and no member, trustee, officer of the company, or any private individual shall be entitled to share in the distribution of any of the company's assets on dissolution of the corporation.

ARTICLE IX.  
DISTRIBUTIONS UPON DISSOLUTION

Upon dissolution of the limited liability company, the sole member shall, after paying or making provision for the payment of all of the liabilities of the company, dispose of all of the assets of the company exclusively for the purposes of the company in such manner, or to a charitable, scientific, religious, literary, or educational organization which at that time qualifies as an exempt organization under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be amended.

ARTICLE X.  
MANAGER-MANAGED LLC

The affairs and property of this company shall be managed and governed by the Manager of the Company. The Manager shall be elected by the member at the sole discretion of the member. The initial Manager of the limited liability company is High Alert Institute, Inc., the address of which is 4800 Ben Hill Trail, Lake Wales, Florida 33898.
