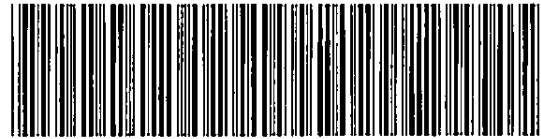



**ARTICLE I. NAME**

The name of the limited liability company is KP2 Orange Tiger LLC (the "Company").
