



STATEMENT OF RELEASE OF NAME RIGHTS

MART STUART DAY (the "Affiant") deposes and states the following:

- 1. Affiant is the Manager of Mary Stuart Day, LLC, a Florida limited liability company assigned Document Number L24000104426 (the "Company") and has personal knowledge of the business and operations of the Company.
- 2. Affiant is an owner of an interest in Mary Stuart Day, a Florida general partnership (the "Partnership").
- 3. On June 17, 2024, the Company filed Articles of Dissolution with the Florida Department of State in order to voluntarily dissolve the Company.
- 4. The Affiant will be converting the Partnership into a new limited liability company with the same name as the Company.
- 5. The Company hereby releases any rights the Company may have to the name "Mary Stuart Day, LLC" agrees that it will not revoke the dissolution, and consents to the adoption of the name "Mary Stuart Day, LLC." by the Partnership.
- 6. This Statement is being made to induce the Florida Department of State to permit the Partnership to convert to a new limited liability company under the name "Mary Stuart Day, LLC."
