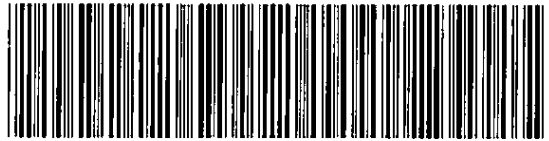

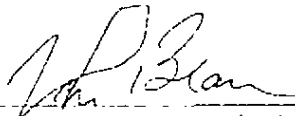
**ARTICLES OF ORGANIZATION
OF

The Articles of Organization presented herein are adopted in accordance with the provisions of the Florida Revised Limited Liability Company Act. 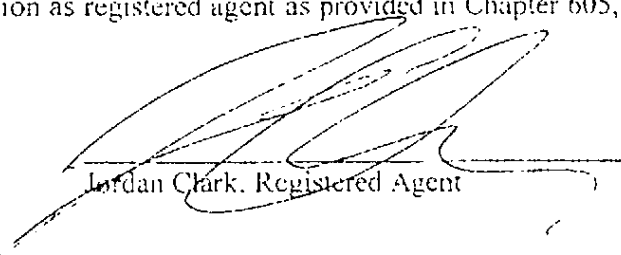
