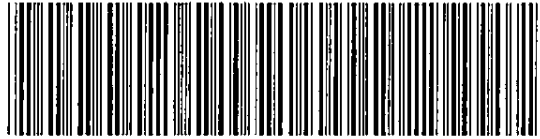

SECOND: The term of existence of the Limited Liability Company shall be perpetual.


