Abbott Jr., a natural person competent to contract and an authorized representative of SAVALOT, LLC, hereby presents these Articles of Organization as the Articles of Organization of SAVALOT, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is SAVALOT, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement of the Company. The name and address of the initial manager of the Company is as follows:

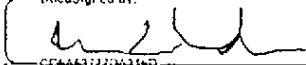

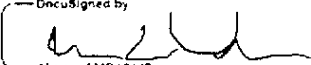
