



The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.


ARTICLE III Purpose

ARTICLE VI Amendment of Articles of Organization and Operating Agreement


These Articles of Organization and the Company's Operating Agreement may be amended at any time by the members.
