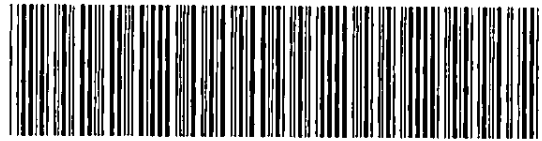

The mailing address and street address of the principal office of the Company is 506 West Ash Street, Perry, Florida 32347.

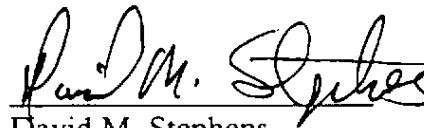
ARTICLE III - MANAGEMENT

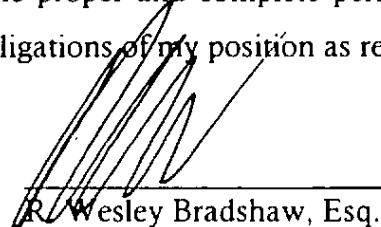
