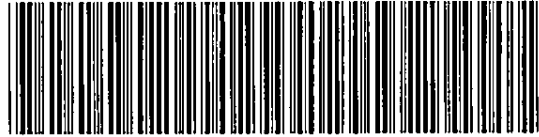

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of J&M Swift Transport, LLC.

SECOND: The original Articles of Organization of J&M Swift Transport, LLC were filed with the Florida Department of State on July 11, 2024, and assigned Document Number L24000309356.
