ARTICLES OF ORGANIZATION

OF

ENTERPRISE CHARTERS, LLC

- 1. <u>Name</u>. The name of this limited liability company is **ENTERPRISE CHARTERS**, **LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").
- 2. <u>Duration</u>. The Company's existence shall be perpetual, and the effective date of commencement of the Company's existence shall be July 9, 2024.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

such Appraisal Rights and agreed and acknowledged that this clause constitutes an express waiver and elimination of all Appraisal Rights for purposes of Section 605.1006(2) of the Act.
