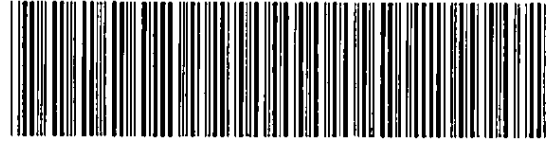

**ARTICLES OF ORGANIZATION

ARTICLE I. NAME

The name of the limited liability company is Rising Tide Investors LLC (the "Company").
