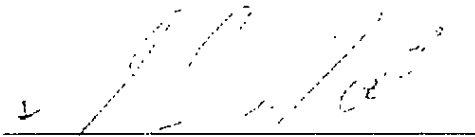
ADMISSION OF NEW MEMBERS

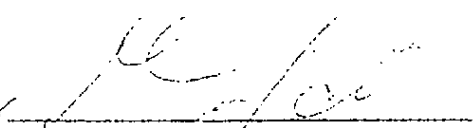
