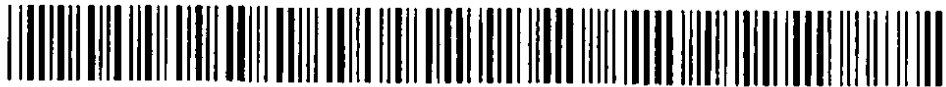

REGISTERED OFFICE AND AGENT
