**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
APOLLO SHIP CHANDLER NO. 22 SUBSIDIARY LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **Apollo Ship Chandler No. 22 Subsidiary LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of Apollo Ship Chandler No. 22 Subsidiary LLC were filed with the Florida Department of State on July 23, 2024 and assigned document number L24000324028.

SECOND: The Company's Articles of Organization are hereby amended by deleting Article I of the Articles of Organization in its entirety, and replacing it with the following new Article III:

THIRD: Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
