ARTICLES OF ORGANIZATION

FOR

SD FARM POLO, LLC

The undersigned, for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is SD FARM POLO, LLC.

ARTICLE II - ADDRESS

The mailing address of the limited liability company is 3500 Fairlane Farms Road, Suite 7, Wellington, FL 33414, and the street address of the principal office of the company is: 3500 Fairlane Farms Road, Suite 7, Wellington, FL 33414.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless sooner dissolved in accordance with the laws of the State of Florida or as provided in this Articles of Organization.

ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to operate the business of SD FARM POLO, LLC, and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

<u>ARTICLE V – ADMISSION OF NEW MEMBERS</u>

New members may be admitted to the Company as may be authorized pursuant to a vote of the majority-in-interest and upon such terms and conditions as shall be determined by the majority-in-interest of the members, or upon such terms and conditions as shall be as set forth in the operating agreement. The majority-in-interest of members or the operating agreement, shall determine the amount and nature of contributions by new members at the time new members are admitted.

ARTICLE VI - CONTINUATION OF BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued by a vote of the majority-ininterest of members, in absence of which the Company shall be dissolved.

ARTICLE VII - MANAGEMENT

The Company shall be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager(s) will serve until the first annual meeting of the member(s) or until their successor(s) become duly qualified and elected.
