

ARTICLES OF ORGANIZATION OF BELLAIR HOTELS, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

<u>Name</u>

The name of this limited liability company (the "Company") shall be:

Bellair Hotels, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

730 S. Atlantic Avenue, Suite 102 Ormond Beach, Florida 32176

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 222 W. Comstock Ave., Suite 200, Winter Park, FL 32789, and the initial registered agent of the Company at such office shall be Alton L. Lightsey. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the Members of the Company. The Operating Agreement of the Company shall be for the

ARTICLE V

Management of Business

The business of the Company shall be managed by Managers elected by the Members as provided in the Operating Agreement. The Managers may be, but are not required to be, Members of the Company. The Managers shall have the power and authority to act on behalf of the Company as provided in Chapter 605, Fla.
