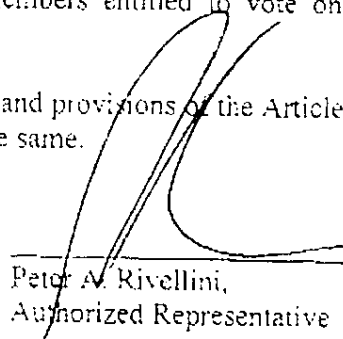
ARTICLE II
