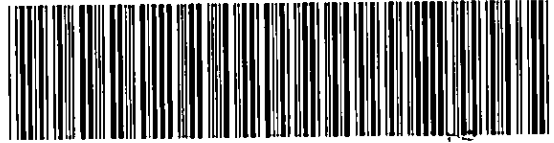

The mailing address and street address of the principal office of the Company shall be Torre Lexus, Piso 2, Ave. Escazu, San Jose, Costa Rica.


**ARTICLE III. REGISTERED AGENT AND OFFICE**
