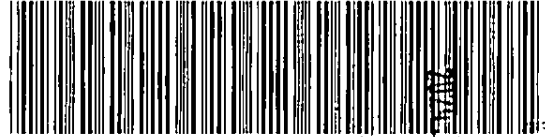

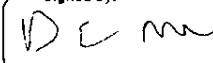
**ARTICLE IV.

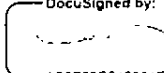
