The date for commencement of the Company's existence shall be July 30, 2024. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


**ARTICLE V - REGISTERED OFFICE AND AGENT**

**ARTICLE VI - MANAGEMENT**


