ARTICLES OF ORGANIZATION
of
135 BETSY LANE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "*Act*"), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be 135 Betsy Lane, LLC (the "*Company*"). The street address of the principal office of the Company shall be 135 Betsy Lane, Athens, Georgia 30606, and the mailing address of the Company shall be 9476 Shortleaf Court, Apopka, Florida 32703.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 


