**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **COA WORLD, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The physical address and mailing address of the Company is **14621 State Road 70 E., #242, Bradenton, Florida 34202.**

The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
